- An <u>authorised body [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] Carrying on a practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#practice] during any indemnity period [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period] beginning on or after 25 November 2019 must take out and maintain <u>qualifying insurance</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] under these rules with a <u>participating insurer</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer].
 </u>
- 3. In respect of its obligation under rule 2.1, an <u>authorised body</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]

Rule 3: Adequate and appropriate insurance

3. Notwithstanding rule 2.1 above, an <u>authorised body</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] must take out and maintain professional indemnity insurance that

- provides adequate and appropriate cover in respect of current or past practice taking into account any alternative arrangements the body or its clients_[https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#client] may make.
- 4. An <u>authorised body [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> must ensure that its <u>clients</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#client] have the benefit of the indemnity insurance required under these rules and must not exclude or attempt to exclude liability below the minimum level of cover required under these rules.

Rule 4: Responsibility

Each <u>authorised body [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u>, and any <u>principal</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of such a body, must ensure that the <u>authorised body</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] complies with these rules.
- 5. If an authorised body [https://jobs.sra.org.uk/solicitors/standards-<u>regulations/glossary/#authorised-body]</u> is carrying on a <u>practice</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#practice] which is being provided with qualifying insurance [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#qualifyinginsurance] by a participating insurer [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#participatinginsurer] (whether alone or together with another participating insurer [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#participatinginsurer]) and that participating insurer [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#participating-<u>insurer</u>] is the subject of an <u>insolvency event</u> [https://iobs.sra.org.uk/solicitors/standards-regulations/glossary/#insolvency-event] then the authorised body [https://jobs.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body] and any principal [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of the body must ensure that the authorised body [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] has in place qualifying insurance [https://jobs.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance] with another participating insurer [https://jobs.sra.org.uk/solicitors/standards-<u>regulations/glossary/#participating-insurer</u>] as soon as may be reasonably practicable and in any event within four weeks of such insolvency event [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insolvencyevent1.

- 9. This rule is in addition to any obligations imposed on the <u>authorised</u> <u>body [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> under the Provision of Services Regulations 2009.
- 10. For the purposes of the <u>SA [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#SA1</u> (including without limitation section 10 of that Act), any person who is in breach of any rule or part of any rule under the Solicitors' Indemnity Insurance Rules 2000 to 2010 or SRA Indemnity Insurance Rules 2011 to 2013 will be deemed, for so long as that person remains in breach, not to be complying with these rules.

1. Scope of cover

1. Civil liability

Subject to the limits in clause 2, the insurance must indemnify each insured [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against civil liability to the extent that it arises from private legal practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#private-legal-practice] in connection with the insured firm's practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice], (including its prior practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#prior-practice] and (unless run-off cover is provided in accordance with clause 5.3) any successor practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice]) provided that a claim [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#claim] in respect of such liability:

- 1. is first made against an <u>insured</u>

 during the <u>period of insurance</u>

2. Defence costs

The insurance must also indemnify the <u>insured</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against defence costs [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] in relation to:

- 1. any <u>claim [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#claim]</u> referred to in clause 1.1; or
- 2. any <u>circumstances [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#circumstances]</u> first notified to the <u>insurer [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insurer]</u> during the <u>period of insurance;</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance] Or
- 3. any investigation or inquiry (save in respect of any disciplinary proceeding under the authority of the <u>SRA</u>

2. Limit of insurance cover

2. Any one claim

 - 1. one act or omission;
 - 2. one series of related acts or omissions;
 - 3. the same act or omission, in a series of related matters or transactions;
 - 4. similar acts or omissions, in a series of related matters or transactions, and
- 2. all <u>claims [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#claim]</u> against one or more <u>insured</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured] arising from one matter or transaction will be regarded as one <u>claim [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#claim]</u>

7. Multiple underwriters

5. No cancellation

The insurance must provide that it cannot be cancelled except (in the case of (a), (b) or (c) below) by the agreement of both the insured firm [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] and the insurer [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insurer], and in any event only in circumstances where:

and for the purposes of this clause 5.3 and clause 5.7, an <u>insured firm's practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice]</u> shall (without limitation) be regarded as ceasing if (and with effect from the date upon which) the <u>insured firm [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm]</u> becomes a <u>non-SRA firm</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#non-SRA-firm].

8. Scope of run-off cover

The run-off cover referred to in clause 5.3 must:

1. indemnify each <u>insured [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured]</u> in accordance with clauses 1.1 to 1.4;

- 2. provide a minimum level of insurance cover in accordance with clauses 2.1 and 2.3;
- 3. be subject to the exclusions and conditions of the insurance applicable in accordance with the MTC
 MTC; and
- 4. extend the period of insurance [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#period-ofinsurance] for an additional six years (ending on the sixth anniversary of the date upon which, but for this requirement, it would have ended, and for the avoidance of doubt, including the extended policy period [https://jobs.sra.org.uk/solicitors/standardsregulations/glossary/#extended-policy-period] and cessation period [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-<u>period</u>],) save that in respect of run-off cover provided under clause 5.3(c), such run-off cover shall not operate to indemnify any regulated insured [https://jobs.sra.org.uk/solicitors/standardsregulations/glossary/#insured] for civil liability arising from acts or omissions of such insured [https://jobs.sra.org.uk/solicitors/standardsregulations/glossary/#insured] occurring after the expiration of the cessation period [https://jobs.sra.org.uk/solicitors/standardsregulations/glossary/#cessation-period].

9. Succession

The insurance must provide that, if there is a <u>successor practice</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice] to the ceased <u>practice</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#practice], the <u>insured firm</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] may elect before its <u>cessation</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#cessation], whether it wishes the ceased <u>practice</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#practice]:

- 1. to be insured under the run-off cover referred to in clause 5.3(a) or
- 2. provided that there is insurance complying with these MTC
 [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#MTC]_in
 relation to that successor practice
 practice], to be insured as a prior practice
 lipids.sra.org.uk/solicitors/standards-regulations/glossary/#prior-practice] under such insurance.

If the <u>insured firm [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm]</u> fails to make an election and/or fails to pay any premium due under the terms of the <u>policy</u> [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#policy], before its <u>cessation [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#cessation]</u>, clause 5.5(b) above shall apply.

10. Suspended practices

The insurance must provide that, where run-off cover has been activated in accordance with this clause 5, but where the <u>insured firm's practice [https://jobs.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice]</u> restarts, the <u>insurer</u>

9. Partnership disputes

12. Withholding assets or entitlements

13. Premium

The premium may be calculated on such basis as the insurer

8. Law and Jurisdiction

indemnity period

means:

- i. in the SRA Indemnity Insurance Rules and the MTC, the period of one year starting on 1 September 2000, 2001 or 2002, the period of 13 calendar months starting on 1 September 2003, or the period of one year starting on 1 October in any subsequent calendar year
- ii. in the SRA Indemnity Fund Rules, the period of one year commencing on 1 September in any calendar year from 1987 to 2002 inclusive, the period of 13 calendar months commencing on 1 September 2003, and the period of one year commencing on 1 October in any subsequent calendar year.
