### **Reasons/basis**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that, whilst working as a solicitor at Kingswright Solicitors Limited, on or around 27 June 2023, he advised a person he believed to be a prospective client to:

1. Provide a false narrative in support of an asylum claim within the United Kingdom; and/or
2. Enter into a marriage, in the absence of a genuine relationship, for the purpose of regulating his immigration status within the United Kingdom.

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.

#### **Decision details**

The SRA has decided that it is in the public interest not to grant Mr Ahmad, who is a solicitor, a practising certificate for 2023/2024. This decision is made without prejudice to any other matters and issues regarding Mr Ahmad.

#### **Reasons/basis**

Mr Ahmad's alleged conduct poses a risk to the reputation of the profession and the trust and confidence the public places in the profession and the provision of legal services. This decision is made having regard to the regulatory objectives contained in the Legal Services act 2007 and in accordance with the regulatory arrangements of the SRA.

- a. refuse your application for a practising certificate, or your application for registration or renewal of registration, in the register of European lawyers or the register of foreign lawyers
